# A Mystery - The Wyoming State Rockhound of the Year Plaque


The Wyoming State Mineral And Gem Society's first Wyoming State Rockhound of the Year was awarded in 2008. From 2008 -2013, the Wyoming State Rockhound of the Year was presented with a jade stone cabochon within a silver bolo made by Jane & Lynn Neale of the Shoshone Rock Club.

Beginning in 2014, the Wyoming WSMGS State Rockhound of the Year was presented with an engraved stone plaque. The "stone" to make these plaques was collected by then President Stan Strike from an Industrial business park being developed in Lusk, Wyoming. This pink and gray stone was mixed in with granite and was part of fill loads at the dead end of one of the new streets.

Anhydrite? This mystery stone was initially identified as anhydrite. It was soft with a hardness of about 3.5 on the hardness scale, had a vitreous luster, and in its massive form, appeared to have cubic cleavage. Color variations of anhydrite, its **continued on page 2**



hardness, cleavage, and luster seem to match our ROY stone, However anhydrite is formed as an evaporative sedimentary deposit and our mystery stone seems to have been associated with igneous granite deposits?

"Anhydrite is an evaporite mineral that occurs in extensive layered deposits in sedimentary basins where large volumes of sea water have been evaporated. It is typically interbedded with halite, gypsum, and limestone in accumulations that can be up to hundreds of feet thick. On a much smaller scale, anhydrite can form in shoreline or tidal flat sediments from the evaporation of sea water. Anhydrite also occurs as a vein-filling mineral in hydrothermal deposits. It is deposited from solution, often along with calcite and halite, as gangue in sulfide mineral deposits. Anhydrite is also found in the cap rock of salt domes and in cavities of trap rock."

"Anhydrite is an anhydrous calcium sulfate with a composition of CaSO4. It is closely related to gypsum, which has a chemical composition of CaSO4.2H2O. The worldwide abundance of gypsum greatly exceeds the abundance of anhydrite. One of the most distinctive properties of anhydrite is its cubic cleavage. It cleaves in three directions at right angles. This can easily be seen in coarsely



crystalline specimens or with a hand lens in fine-grained specimens. This distinctive cleavage has earned anhydrite the nickname of "cube spar." Anhydrite can be a small challenge to identify when it occurs in massive form. It can be confused with gypsum, calcite, or halite - which it is almost always associated with. Compared to gypsum, anhydrite exhibits cleavage in three directions at right angles and has a greater hardness. Its right angle cleavage and lack of acid reaction allows it to be distinguished from calcite. Compared to halite, anhydrite is insoluble and slightly harder."

Rhodenite? At the 2018 WSMGS State Mineral and Gem Show, the composition of the Wyoming state ROY plaque was identified as rhodenite. Rhodenite's physical properties matches our WSMGS ROY plaque as

to color variations (pink & gray), cleavage(almost cubic) and vitreous luster but its hardness is 5.5 to 6.5 and its surface is streaked with black lines from manganese oxides.

"A closely related mineral is Rhodochrosite, which has similar properties as rhodenite. Fun Fact: Can't tell Rhodochrosite and Rhodonite

Look for the black lines or "roads" in Rhodonite as opposed to the creamy loops and swirls in Rhodochrosite.

Quartz being a silicate/quartz composite. It is manganese that brings out the rosy color Rhodonite is known for. Although, unlike Rose Quartz, Rhodonite forms slowly and more patiently, allowing the manganese to meld and morph with a number of other minerals such as calcium and aluminum during the sedimentary process. When the manganese is exposed it will oxidize and as the minerals weather together this is the process that creates the lovely colored veins." .[Reference: https://www.shimmerlings.com/gemstones/rhodonite/]

Thulite? By doing internet research, another possible identification of the material making up the Wyoming State ROY plaques may be the mineral thulite. Thulite's color is usually pink but can vary from pink depending on the concentration of manganese which may cause Thulite to contain black, grey, and white material. In addition to the color matching our ROY plaques it has a vitreous luster and is often mottled color with white calcite and occurs as veins and fracture fillings within many rock types such as granite. However, its hardness is usually 6.5 and has cleavage only in one direction which does not agree with our ROY material with a hardness of 3.5 and has cubic cleavage?

"Thulite (sometimes called rosaline) is an opaque, massive pink manganese-bearing variety of the mineral zoisite with a chemical formula of (Ca2Al3O(OH)(SiO4)(Si2O7)). Its Mohs hardness is 6-7, has vitreous luster, and perfect cleavage in one direction." [Reference: https://www. spiritofisis.org/knowledge/crystal\_files/thulite. htm]

"Manganese can substitutes for calcium in the mineral giving it a black, grey, and white color. Thulite is often mottled with white calcite and occurs as veins and fracture fillings transecting many types of rock. Thulite may sometimes refer to any pink zoisite. However, thulite from granite pegmatites and some metamorphic rocks is frequently the clinothulite variety of clinozoisite and not true zoisite.

Clinothulite is the manganese bearing variety of clinozoisite. Clinothulite is pink, manganeserich variety of the mineral Clinozoisite. Zoisite and Clinozoisite are very similar minerals, differing only in crystal structure. This makes Thulite and Clinothulite almost identical, and sometimes it is impossible to make a distinction without complex tests.

Thulite is most similar to Rhodonite, though it usually lacks the black streaks often present in Rhodonite. Thulite also lacks the banding of Rhodochrosite and is harder." [References: http://www.gemstonebuzz.com/thulite, https://www.mindat.org/min-3955.html ]

At this time, what mineral makes up our Wyoming State Rockhound of the Year plaques remains a mystery. Anhydrite seems to match more of our ROY plaque's physical and chemical properties than Rhodenite and thulite/clinothulite but seems to have been part of an igneous rock deposit rather than from its formation in a sedimentary environment. More investigation in Lusk, WY may answer our question-perhaps finding the company that hauled in the fill rock.....? The mystery continues but we will continue to work towards a solution.

#### **Dear Regional Federation Presidents,**

You can help by distributing information on this issue to your clubs, by co-signing our comment letter or writing your own, and by suggesting that your member clubs consider co-signing our comment letter and that their members make individual comments. Time is of the essence, since the comment letter and supporting information needs to be reviewed by club officers and voted at their November board meetings, for responses to meet the deadline for submitting com-

ments.

The BLM is proposing to reopen lands in southern Utah to hobby collecting, but they need to hear support from the public. They have solicited comments from interested individuals and organizations. Unfortunately, many

conservation organizations are commenting against hobby rock collecting, and these organizations are asking their members to send comments against it. If rock hounds fail to speak up now in favor of hobby collecting, the BLM may have to abandon that part of their "preferred alternative" due to a preponderance of negative comments.

The BLM is proposing to reopen to hobby rock and fossil collecting not only the land removed from the GSENM (the KEPA), but to allow hobby collecting within specific areas inside the (remaining) GSENM. This would be an important precedent, relevant to management of several recently declared monuments in California and existing monuments elsewhere.

### Letter from WSMGS Pres Jim Gray to Forest Service

This letter is in response to the implementation of changes to access in some areas of the Bridger-Teton National Forest, in particular, Spread Creek/Toppings Lake drainages, Shadow Mountain, lower Gros Ventre drainage, the Curtis Canyon/lower Flat Creek drainage, Curtis Canyon campground, Cache Creek, and the Gros Ventre Wedding Tree.

Although the concept of dispersed camping sounds like a mutually beneficial idea – good for the environment and good for the users – it does not appear to adequately address the situation. Please allow me the opportunity to elaborate. As a lifelong resident (67 years) of Wyoming and a user of our public lands and National Parks, I believe in finding a balance between use and protection. The number of

visitors to our public lands and National Parks has increased in recent years. For example, the visitors to Grand Teton National Park are shown below in part (copied from NPS Stats, National Park Service Visitor Use Statistics):

With an increase in use there are certainly issues, as described by District Rangers, Mary Moore and Todd Stiles, in the October 3, 2018, USDA News Release including fire, litter and waste, and environmental damage from unauthorized off-road vehicle use. I do not disagree that some impact from use occurs, but I question that restricting access is a desirable response. It appears that with each additional restriction, road closure, campground elimination, and wilderness study area that our public lands become increasingly inaccessible to the majority of people. We are being penalized for the improper actions of the few users who do not respect the privilege of using our public lands. Perhaps there are better solutions?

I believe caution should be used in making public access more difficult or eliminating it altogether in one area because then it seems like making similar decisions in other areas gets easier and easier. Additionally, closures and restrictions that are small in one place accumulate to ever greater reduced access to public lands overall. Also by increasing restrictions in one area the use and possible negative impact to neighboring areas is likely to increase. It is important we consider all of the possible uses of our public lands including camping, hiking, bird watching, photography, rock collecting, hunting, and fishing by adults, youth, seniors, and disabled visitors. The purpose and goal of the U.S. Forest Service was originally stated by Gifford Pinchot, first Chief of the Forest Service: "to provide the greatest amount of good for the greatest amount of people in the long run." I believe, we, as rock hounds of America need to help keep public land in the hands of the public for future generations to enjoy, at the same time preserve the geological futures and the beauty of our land for all.

Tapiromorph fossil on display at Wyoming State Museum

Earlier this year, the WSGS had a rare mammal fossil prepared for future scientific evaluation. The fossilized tapiromorph specimen was discovered near Kemmerer, Wyoming, and is the largest known mammal fossil ever found in the 50-million-year-old Green River Formation. It's also the first of its kind found in the geologic formation, potentially is the only one of its kind, and may support a North American origin of tapiroids.

More than 400 people turned out for a week long open house at the WSGS to see the tapiromorph fossil, and another 50 attended an event at the Wyoming State Museum in Cheyenne.

New WSGS Pamphlet Highlights Seminoe State Park's Geology

The Wyoming State Geological Survey (WSGS) has released a new publication about the geology in Seminoe State Park in south-central Wyoming. The pamphlet highlights the park's rock formations, sand

dunes, and hydrogeology.

"Seminoe State Park has some of the most spectacular geology in Wyoming," says WSGS Director, Dr. Erin Campbell. "It's rare to have such a complete geologic section, from Precambrian to Cretaceous rocks, so beautifully exposed and easily accessible."

Readers of the "Geology of Seminoe State Park" pamphlet will learn that the area's oldest rocks – granite and other metamorphic rocks – are at the north end of the park and make up the core of the Seminoe Mountains.

They will also learn that Seminoe Reservoir can hold more than one million acre-feet of water (1 acre-foot=326,000 gallons), most of which originates as snowpack in the nearby Medicine Bow, Sierra Madre, and Shirley mountains. The reservoir's largest inflow is the North Platte River, which is an important tributary to the Missouri-Mississippi River System and a major source of municipal water for several Wyoming cities.

The pamphlet is the second in a series about the geology of Wyoming's state parks. The first focuses on Curt Gowdy State Park in the southeastern corner of the state.

"The WSGS is pleased to provide these geology pamphlets for the state parks," says Campbell. "We hope they will help increase visitation to the parks, as well as help visitors understand the geology around them."

The pamphlets are free and available at the WSGS office on the University of Wyoming campus in Laramie, as a download from the agency's website, and at their respective park's visitor centers. Pamphlets now in production will focus on Glendo and Guernsey (eastern Wyoming), Buffalo Bill (northwestern Wyoming), and Keyhole (northeastern Wyoming).






## WYOMING ROCKSTAR AWARD-WAYNE SUTHERLAND Interview by Aleta Baltis

Wayne Sutherland has gone above and beyond his job at the Wyoming State Geological Survey to benefit Wyoming rockhounds. For many years, Wayne has shared his earth science knowledge with Wyoming residents around the state by providing educational programs to Wyo rock clubs, school students, and at Wyoming Mineral and Gem Shows. He is a real asset to the Wyoming State Clubs by being available to answer questions and to provide educational materials. Wayne has also judged display cases and provided table displays of Wyoming Geological Survey publications at many WY Mineral & Gem shows.

Sutherland has worked more than 40 years as a geologist for private companies and government agencies in Wyoming, Montana, and Utah. His training and experiences include: gold and other metals, diamonds, gemstones and lapidary materials, coal, oil and gas, uranium, industrial minerals, mining claim evaluation, and federal mineral regulations.





Wayne is an amateur radio operator (NQ7Q) and enjoys hiking and other outdoor activities. He and his wife hiked the length of the Wind River Mountains in 1983. In 2003, they self-published a novel: Yellow stone Farewell — a geologically oriented fictional account of a major erup tion of Yellowstone. Wayne also enjoys wood burning custom-made walk ing staffs and other items.

He has recently worked with Professor Dr. Kevin Chamberlain to find modules of pre-Cambrian within the Green River basin so it can be corre lated with other Precambrian in other regions of the world. The best sources of the nodules are in volcanic deposits such as within the Lucite Hills.

His ongoing projects are investigating the occurrence of Wyoming jade, which he hopes to publish soon, and an internet program of Wyo ming mine locations and their associated minerals.

Wayne wants to thank all the rockhounders in Wyoming for being so great about bringing him information and sharing their finds with him.

He thinks it is great having a two-way street For sharing information.

# **LAPIDARY HINTS**



#### **ROCK SAWS:**

1. If your slab saw has a viewing window, add a few drops of liquid detergent to the oil This will help to keep the window cleaner so you can watch the action of the blade interacting with the material being cut.

2. When cutting a nodule, cut through the largest dome to expose the best surface. When cutting geodes, cut through the center plug to expose the best inner features. When cutting petrified wood cut across the grain for the best viewing result.

3. When cutting jade, it will clog the saw blade. Be certain to clean and sharpen the blade after cutting jade by cutting through silicon carbide Bricks of silicon carbide can be purchased from Harbor Freight. When cutting hard rock material, it is best to sharpen your saw every few cuts.

4. To remove cutting oil from a recently cut specimen, soak it in a concentrated solution of hot water and dish washing detergent OR rinse it in soapy water and bury in Kitty Litter.

5. Saw oil needs to be filtered frequently, depending on usage, to rid it of small rock particles that when cycled through the saw blade during cutting will accelerate wear on the blade. Start by draining the "dirty" oil from the saw into a clean container, allowing it to set until the solids have settled to the bottom. Then slowly pour the cleaner oil on the top of the container into the filter system first, followed by the remaining solid contents. The filter system that can be used to clean and reclaim the expensive cutting oil is to position a double layer of paper grocery bags or a shop vacuum filter with its top cut off inside a plastic pail which has small drain holes drilled through it's bottom. Position this pail over a larger plastic collecting container or directly over the saw unit. Allow several weeks for the oil to work its way through the filter. This method should allow you to recycle about 50% of the cutting oil. The solid material caught by the filter should be put into a sealed bag and trashed.

[\*Mineral oil is sold in Farm Supply stores as Horse Laxative and is cheaper than lapidary mineral oil.]

August 2018: Twenty-nine people attended the Shoshone Rock Club meeting to hear a presentation by Gretchen Hurley, a geologist in the Cody office of the U.S. Bureau of Land Management. The meeting took place at the Powell Branch Library on August 14, 2018.

Hurley is involved in paleontological resources in Northwestern Wyoming. She gave a comprehensive and informative program on the fossils of the Big Horn Basin, illustrated by charts, maps, photographs and other materials in a PowerPoint presentation, much to the appreciation of her audience. Highlights are as follows:

• Fossils began forming in the Big Horn Basin 600 million years ago. Famous formations are the Monson and Sundance from the Jurassic period, the Cloverly and Lance from the Cretaceous period, and the Fort Union from the Paleocene period. Christmas party dates need to be set as soon as possible wherever our location is to be as party venues are getting full already. Iris made the motion to hold a Christmas party, Ross seconded. The motion was passed unanimously. Nella made an additional motion for the club to

pay for dessert. Iris seconded the motion. The motion was passed unanimously.

The club members agreed that the party last year at the golf club was enjoyable and it would be a good venue again for this coming year. The committee will try to have possible dates available for the club's vote by next meeting.

• Paleontologists began working in the Basin in the 1880s, excavating specimens from the Jurassic and Cretaceous periods.

• Hurley discussed specific locations around the Big Born Basin, and which formations were there, along with the ages and types of specimens that are being found in each. She mentioned that the Eocene Willwood formation is world famous for mammal fossils found there; dinosaurs had become extinct by then.

• The program ended with a discussion of Natural Trap Cave, a Pleistocene mammal pitfall in the Bighorn Mountains of Wyoming. Hurley was able to provide fascinating details, as she has been in down in this cave. She said that, while no deer were found in the cave, fossils and bones of mice, weasels, martens, bison, Colombian mammoths, dire wolves and short-faced bears had

been found, as well as American lion. Her dramatization of a mammoth falling 80 feet down into the cave was most entertaining.

#### September 2018


Clarence "Doc" Ellis was the presenter at the September 11 meeting of the Shoshone Rock Club. He spoke about local minerals. He said most specimens of various kinds are very weathered and have deteriorated in the exposed areas.

There are not a lot of minerals in the Big Horns. Minerals can be found in the Henderson Mine out of Cooke City, Montana, if approval is granted. Magnetite and other minerals can be found in the Owl Creek area. Magnetite turns to hematite, banded iron that has a reddish streak.

Ellis said calcites are formed in various colors. Copper turns to green malachite; azurite is blue. Chrysocolla is blue to green. Bornite has a purple cast. Iron can be red, yellow or green. Blue is usually due to copper. Limonite is yellow, but the term limonite is not used anymore. It is without form or definite crystalline structure, and it often contains significant amounts of iron oxide minerals such as hematite and goethite. When a club member asked where soapstone might be found, Ellis suggested checking the Beartooth Mountains. He noted that amphibole asbestos causes cancer, but another type of asbestos called chrysotile is not harmful. Sixteen people attended the presentation, which was hosted at the Powell Branch Library by Mary Ann Northrup and Linna Beebe, who teamed up to provide refreshments.

Ellis said it is very helpful to have a good book for reference in the field. He recommended Clarence "Doc" Ellis highly recommended Rocks and Minerals by Martin Prinz, published by Simon and Schuster, as a good resource for assistance with mineral identification, With 1000 illustrations and 600 in full color, it helps to identify a mineral you

may run across in the field. I ordered the book online and it was very reasonable. "Simon & Schuster's Guide to ROCKS AND MINERALS", as an easy to use field guide. Edited by Martin Prinz, George Harlow & Joseph Peters, the
